AIRTIME & OTHER CHARGES

Customer agrees that the purchase of prepaid **Basic Rate Minute(s) or BRM** as specified on this agreement is a non-refundable up-front purchase, and there is no refund for unused prepaid BRM after the rental. The Customer agrees to pay **\$1.99 per BRM** for all usage in excess of the prepaid BRM purchase. One BRM of usage is charged for each actual minute of usage for the call types described as Basic Rate (see chart). Some

call types are billed at rates that are higher or lower than the Basic Rate (see chart). For example as shown in the chart, the Customer is charged nine BRM for each actual minute of usage for calls to other satellite networks such as Inmarsat or Thuraya. Call detail records (CDRs) are not included with this rental. For an additional \$20 charge, Customer can request CDRs as long as the request is made within 30 days of the return of the equipment.

LIMITATIONS: This rental uses a prepaid SIM card and the number of minutes remaining on the prepaid SIM card account is announced at the beginning of each voice call by an automated attendant; this balance is not related in any way to the number of prepaid BRM purchased by the Customer at the beginning of the rental. The prepaid SIM card account balance is monitored each business day and additional BRM are loaded as necessary to maintain a minimum balance of 120 BRM on the prepaid SIM card account. The Customer understands that if the prepaid SIM card balance reaches zero, it will automatically bar further usage until additional BRM are loaded onto its account. The Customer understands that it is possible to use all the BRM on the prepaid SIM card account in a single day. In the unlikely event that prepaid SIM card balance is exhausted, Outfitter Satellite will detect this condition and reload during the next business day, meaning that the Customer will be without service until that reload occurs. If a reload fails to occur after 1 business day, a rental credit of \$10 for each additional day in which a zero balance exists will be issued.

LIABILITY FOR LOST OR DAMAGED EQUIPMENT AND SIM CARDS: An Iridium 9505A Rental Kit with Softcase has a retail value of \$1310. An Iridium 9555 Rental Kit with Softcase has a retail value of \$1615. Here is a list of retail values for individual components or optional accessories which would be used to determine the replacement cost for lost or damaged equipment: Iridium 9505A without battery or stick antenna (\$995); Iridium 9555 phone core without battery (\$1350); stick antenna for 9505A (\$199); leather holster (\$45); hardcase (\$49.95); solar panel with battery pack (\$175); Internet/Data Kit for 9505A (\$180); Internet/Data Kit for 9555 (\$45); PCMCIA-to-Serial Adapter (\$179); High Cap Battery for 9505A/9555 (\$99); Docking Station with Privacy Handset for 9505A (\$395); AC Charger & 5-piece international plug kit (\$105); 5-piece international plug kit alone (\$30); DC Charger (\$65); portable auxilliarily magnetic-mount antenna with 1.5-m cable (\$105); antenna adapter for 9505A or 9555 (\$45); magnetic-mount car antenna with 5-meter cable (\$199); mast antenna (\$199); 10-meter TNC-to-TNC cable (\$99); Padded Softcase (\$20); If a prepaid SIM card is lost or destroyed there is a \$125 fee. Customer is responsible for airtime usage that occurs prior to Outfitter Satellite canceling service on the card (which can take up to 48 hours after Customer notifies Outfitter Satellite in writing that the SIM is lost).
