Terms on Monthly-Billed Plans:

- Monthly Bundle applies only to Basic Rate Calls made using the Iridium GO! device. Other types of
 calls are not included in the Monthly Bundle. Unused parts of the Monthly Bundle are lost and do not roll to
 a subsequent month. Basic Rate Calls include mobile-originated voice calls to cellular, PSTN, Iridium
 numbers and Iridium voicemail. For all plans except the GO-150 UNL Plan, GO! Internet Calls are also

SMS messages sent on this plan from a non-Iridium GO! device are not considered GO! SMS messages and will be billed at a higher rate of \$0.55 each. Calls to Inmarsat, Thuraya & other Mobile Satellite Networks (MSS) is billed at the "All other call types" rate. Inbound Calls: 2-Stage Dialing calls are made by dialing 480-768-2500 (U.S. number) and entering the 12-digit Iridium mobile number. +1 Access calls received through an optional U.S. phone number assigned to the Iridium device. It is important to understand that 2-Stage Dialing or +1 Access calls that are forwarded to Iridium voicemail or another third party number will be billed to your Iridium account. Inbound calls direct dialed to the Iridium 12-digit mobile number are paid by the calling party through their own carrier, and no charge applies to the Iridium phone's account for receiving the direct dialed call.
- Payment Method: Credit approval is based on a valid U.S. credit card, substantial deposit, approved

GO!-SMS refers to messages sent from an Iridium GO! device. Outbound SMS messages can be up to 160 characters. Long SMS messages up to 1000 characters are billed as a series of separate SMS messages of 160-character length (or less). Undeliverable SMS related to mail filters and other non-Iridium issues are charged to the prepaid account. Inbound SMS reception is free.

VALIDITY EXPIRATION DATE: A prepaid account's initial validity expiration date is equal to the validity associated with the first voucher applied to the account relative to the activation date.
