Dear Outfitter Satellite Customer:

Effective April 1, 2016, any Inmarsat FleetBroadband SIM card active on the FleetBroadband **FBB+2400MB** plan (which has been discontinued) will be transitioned to the FleetBroadband **FBB+3000MB Plan** upon fulfilling its current 12-month term. The annual fee of the FBB +3000 MB Plan is \$15,400 (which is higher than the annual fee of the original FBB+2400MB plan which was \$13,080). The new plan increases the number of bundled megabytes of Standard IP data included each year to 3000 MB and increases the out-of-bundle Standard IP data rate to \$8.95 per MB. Effective April 1, 2016, any Inmarsat FleetBroadband SIM card active on the FleetBroadband **FBB+24GB** plan will be transitioned to the FleetBroadband **FBB+48GB Plan** upon fulfilling its current 24-month term. The annual fee of the FBB+48GB Plan is \$27,033.60 (which is identical to the annual fee of the original FBB+24GB plan). The new plan increases the number of bundled megabytes of Standard IP data included each year to 49,152 MB and reduces the out-of-bundle Standard IP data rate to \$0.85 per MB.
